Clinical trial patient pathway timeline

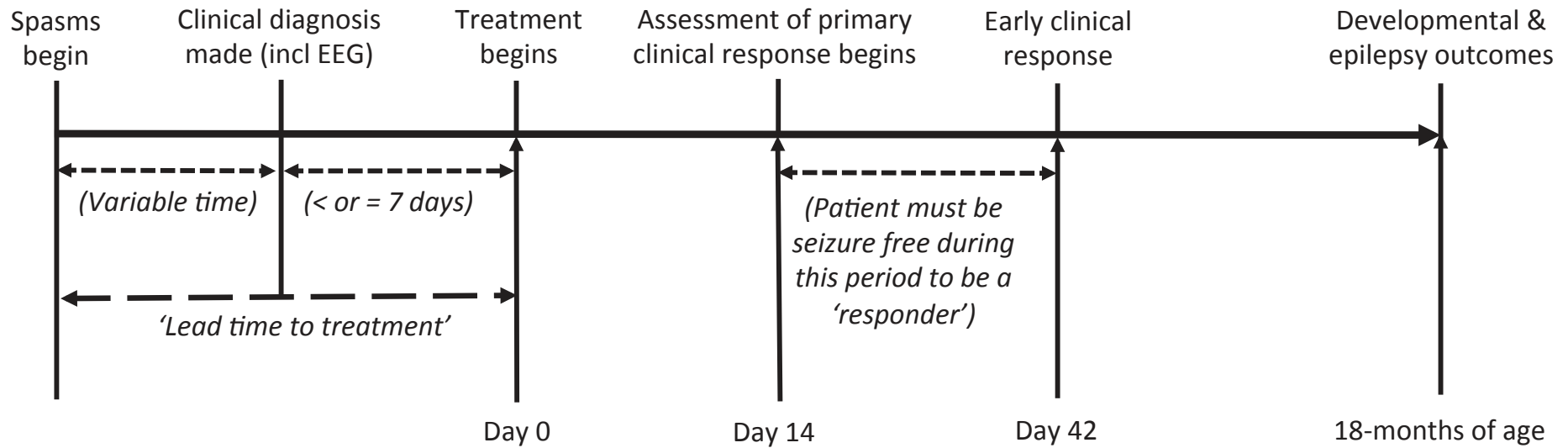
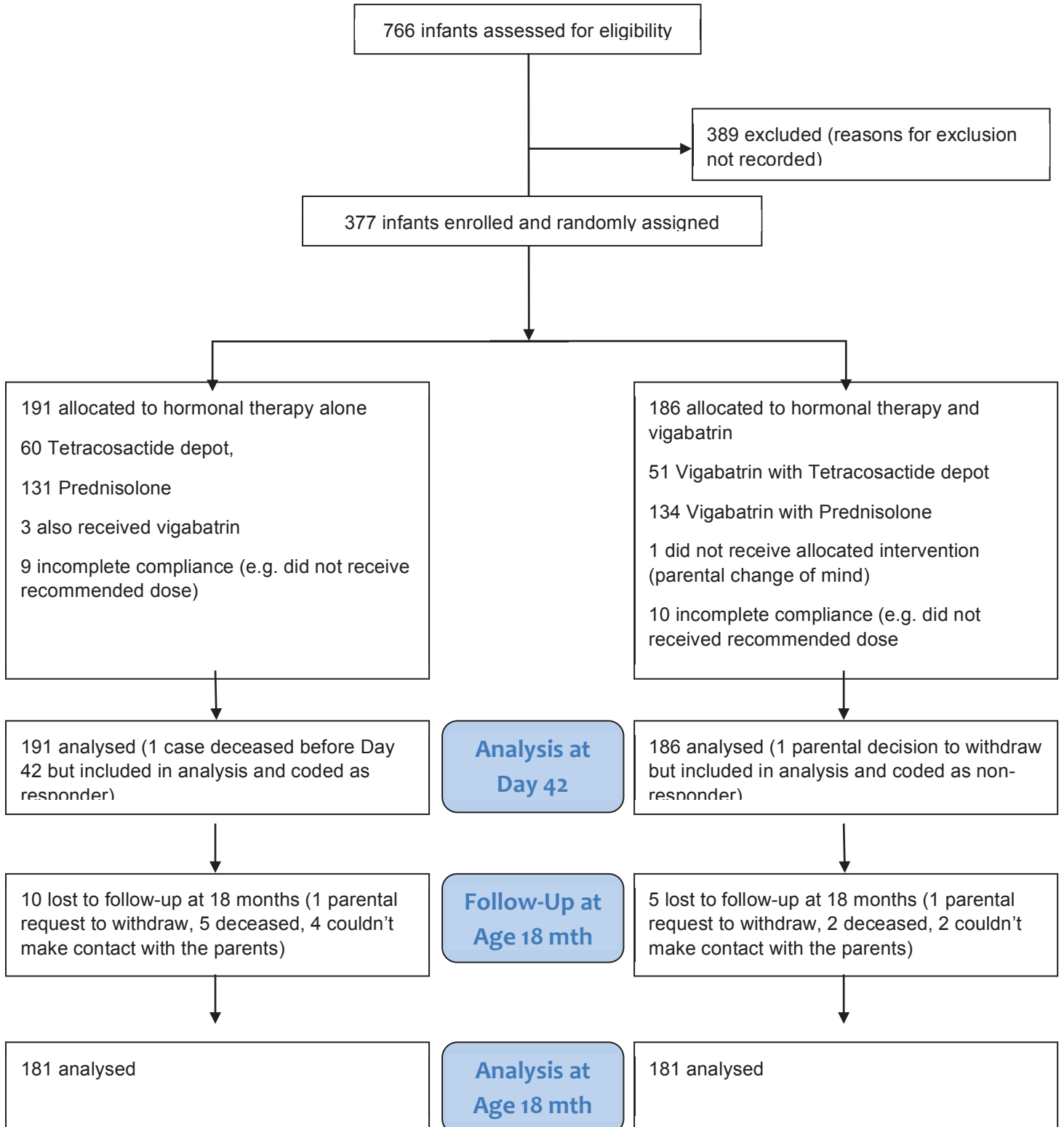
